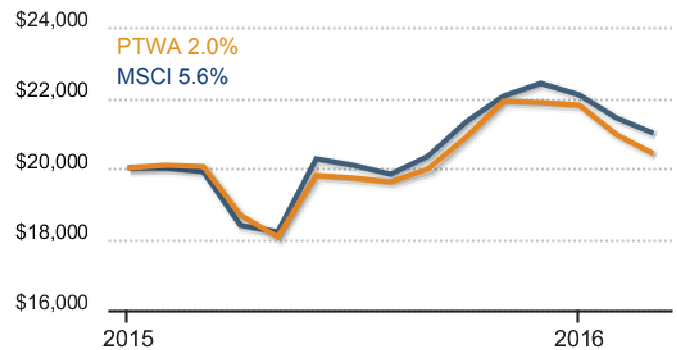
Investment objective
