### Investment objective

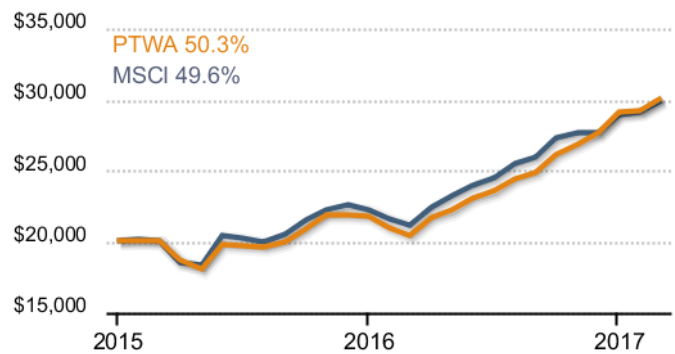
